Frequently Asked Questions

Board of Governors' Dental Scholarship-Loan Program (BGDSL) is a scholarship-loan program which means funds received through this program must be repaid either through service or cash.

NEW AND RENEWAL APPLICANT QUESTIONS:

- Q1. How can I apply for a BGDSL?
- Applicant must sign and submit a completed application to the Dental School at UNC-CH to be forwarded to SEAA with supporting documentation
 - Complete the FAFSA, listing UNC-CH Dental School, and submit it to the Central Processing System in a timely manner
 - Submit additional documentation or information in support of the application in order to substantiate information presented in the application before the Dental School considers the application for a Scholarship-Loan or before SEAA approves a Scholarship-Loan for disbursement. The supporting documentation may include information about income and assets of the student's parents.
- Q2. How many scholarship-loans are available?
- A maximum of eight recipients will be selected each year.
- Q3. When may I apply?
- The application period usually opens in February with a May 15 deadline.
- Q4. What are the eligibility criteria?
- Recipients are selected based on financial need, merit, North Carolina residency and must fulfill the following:
- Comply with the application procedures set forth in the Program Policies
 - Enroll or be accepted for enrollment, on a full-time basis in the Dental Program at UNC-CH
 - Qualify as a North Carolina resident for tuition purposes
 - Meet or exceed the Program Standards
 - Comply with the registration requirement of the Military Selective Service Act or be exempt from the registration requirements
 - Not be in default, nor owe a refund, under any federal or State loan or grant program and
 - Agree to be licensed to practice dentistry in North Carolina.
- Q5. Is the scholarship-loan renewable?
- Yes. The scholarship is renewable for a maximum of four years, provided the recipient
 - Has continued financial need
 - Maintains satisfactory academic progress
 - Remains interested in dental practice in North Carolina
 - Is honoring the terms of the recipients Promissory Note
 - Remains eligible under the Program Policies and
 - Is continuously enrolled as a full-time student in the Dental Program.

- Q6. What is the value of the scholarship-loan?
- The scholarship-loan provides an annual stipend of \$5,000 plus tuition, mandatory fees, medical insurance, a laptop computer and required dental equipment. The scholarship-loan amount is established by the General Assembly or set by SEAA based on the total appropriation for the Program.
- Q7. Am I required to sign a Promissory Note?
- Yes. A scholarship-loan must be evidenced by a Promissory Note, properly executed by the student and the notary public who witnesses the student's signature.
- Q8. When will I receive my scholarship-loan funds?
- SEAA will disburse the proceeds of the scholarship-loan by electronic funds transfer to the Dental School.
- Q9. May I use the proceeds of the scholarship-loan for purposes other than the cost of attendance at the Dental School?
- No. Proceeds may only be used for payment towards the cost of attendance at the Dental School.
- Q10. May I take a leave of absence?
- Should you take a leave of absence during your training period, you forfeit that year's funding. If you received funds for your 1st and 2nd years, then take a leave of absence in your 3rd year, you have only one year of eligibility remaining.
- Q11. May I postpone receiving my award?
- No. If you are approved and do not accept the funds, you lose your chance to reapply. Only 1st year students may be considered.
