Is it Time to Have Your Student Re-Evaluated?

Deadline Approaching for Evaluations Prior to January 2020

Families must provide a re-evaluation of their student's disability every three years to remain eligible to participate in the ESA+ program. You received an email reminder in MyPortal if it is time for your student to be re-evaluated.

The re-evaluation deadline is **June 1 if your student's evaluation on file took place before January 1, 2020**. If the update is not submitted by the deadline any renewal submitted will become invalid, spring funds will be forfeited, and your student will be unable to continue in the program for the 2023-2024 school year.

Re-evaluation options:

If the primary or secondary disability listed on the student's Eligibility Determination has not changed, families have two options for re-evaluation:

1. Public School Eligibility Determination: The local public school system assesses the student to determine if the student continues to be a child with a disability. The document to submit to ESA+ is the Eligibility Determination issued by the IEP team.

2. Psychologist Assessment*: A North Carolina Licensed Psychologist with a school psychology focus or a North Carolina Licensed Psychiatrist assesses the student. The document to submit to ESA+ is the <u>Continuing Eligibility Form</u>. ESA+ funds may be used for the assessment if the provider is approved and registered with the ESA+ program.

*Exceptions to Psychologist Assessment Option: The Psychologist Assessment cannot be used to document a change in the area of disability, or if the student's only disability designated on the IEP Eligibility Determination is Developmental Delay.
